



#### 2020 Annual Dues are Due.

Our dues pay for the upkeep and repairs to the front of our neighborhood. We take pride in the look of our entrance and it helps to keep our property values up as a community.

Some fees are consistent charges for mowing and electricity but sometimes there are projects that occur. Last year we had a tree fall and it was time to refresh the sealant and paint to the monuments.

Our websites, mailbox and community administration also have yearly fees.

In addition to these fees, our volunteer board and contributing residents spend a considerable amount of time managing activities for the benefit of everyone, and these are at no charge.

We would like all our residents to contribute so we can offer additional benefits to the community besides the bare minimum maintenance. Currently about 30% of residents are supporting all the maintenance activities for the entire community. We are fortunate to have a Neighborhood Association instead of a mandated Home Owners Association but there are still required fees and donated time and effort.
